## **EXECUTIVE ORDER NO. 17-131**

## CREATING THE PERFORMANCE CHALLENGE FUND (PCF) IMPLEMENTATION UNIT OF BAYOG, ZAMBOANGA DEL SUR

WHEREAS, R.A. 7160 otherwise known as the Local Government Code of 1991, provides among others, that LGUs assume the primary responsibility of providing basic services and facilities and improvement of quality of life of its constituents through implementation of various programs and projects;

WHEREAS, the Department of the Interior and Local Government (DILG) has among its programs is the Performance Challenge Fund (PCF) to serve as facility to help stimulate LGUs that put premium on transparency, accountability, and service delivery performance to enable themselves to avail financial support to jumpstart and sustain local socio-economic development initiatives supportive of national goals and priorities;

WHEREAS, the Municipal Government of Bayog, Zamboanga del Sur, having been awarded the Seal of Good Local Governance (SGLG) is a recipient of PCF Incentives and that the same earmarked for the "Concreting of Depase-Balumbunan Road Section" it being identified as PCF project;

WHEREAS, prosecution of the PCF Project is subject to creation of an LGU PCF Implementation Unit responsible for the purpose;

NOW, THEREFORE, I, LEONARDO L. BABASA, JR., Municipal Mayor, by virtue of the powers vested in me as Local Chief Executive of the Municipality of Bayog, Zamboanga del Sur, do hereby Order:

SECTION 1. CREATION OF THE PERFORMANCE CHALLENGE FUND (PCF).—the Performance Challenge Fund (PC) Implementation Unit is hereby created to perform duties and responsibilities stipulated in succeeding sections hereto.

SECTION 2. COMPOSITION. The PCF shall be composed of the following which could be augmented as the need arises:

SECTION 3. The PFC Project Implementation Unit, shall manage and oversee the implementation of the project. It shall be responsible for:

- 1. Effective overall implementation and management of the project;
- 2. Procurement activities related to the implementation of the project;

3. Supervision, monitoring and evaluation of the project implementation;

4. Ensuring the provision of the LGU equity and O&M requirements of completed facilities in the LGU Annual Budget;

5. Ensuring the availability of the beneficiaries' counterpart share of the total project cost;

6. Implementation of the financial management system for the subproject;

7. Coordinating all activities undertaken in relationship to the subproject;

8. Adherence to the environmental requirements and other social safeguard measures; and,

9. Compliance to DILG reporting requirements.

SECTION 3. EFFECTIVITY. This Order shall take effect immediately.
