EXECUTIVE ORDER NO. 17-132

CREATING THE PRICE MONITORING COMMITTEE (PMC) OF THE MUNICIPAL GOVERNMENT OF BAYOG, ZAMBOANGA DEL SUR, FOR PURPOSES OF PROCUREMENT OF GOODS, INFRASTRUCTURE PROJECTS AND CONSULTING SERVICES

WHEREAS, provisions of R.A. 7160 otherwise known as the Local Government Code of 1991, Section 356 of its Implementing Rules and Regulations declares that acquisition of supplies by local government units shall be through competitive public bidding, subject to applicable law, rules and regulations.

WHEREAS, Rule IX, Section 31.2 of the Revised Implementing Rules and Regulations of R.A. 9184 (Government Procurement Reform Act) provide among others that Procuring Entity has procedures to ensure that the Approved Budget Ceiling (ABC) is based on recent estimates made by a responsible unit on prevailing market prices associated with the types of goods or infrastructure projects to be procured.

WHEREAS, it becomes impending to create a Price Monitoring Committee to deter potential over pricing of goods, materials, and services thereby ensuring procurements better and advantageous to the the Municipal Government of Bayog, Zamboanga del Sur;

NOW, THEREFORE, I, LEONARDO L. BABASA, JR., Municipal Mayor, by virtue of the powers vested in me as Local Chief Executive of the Municipality of Bayog, Zamboanga del Sur, do hereby Order:

SECTION 1. CREATION.– The PRICE MONITORING COMMITTEE (PMC) is hereby created in the Municipal Government of Bayog, Zamboanga del Sur, for purposes of procurement of goods, infrastructure projects and consulting services, composition and functions, duties and responsibilities of which, as are stipulated in succeeding sections hereto.

SECTION 2. COMPOSITION. The PMC shall be composed of the following Officials and Employees, which could be augmented as the need arises:

SECTION 3. The Price Monitoring Committee (PMC) shall have the following functions, duties and responsibilities:

1. Establish and occasionally update Price Monitoring List of Estimates of supplies and materials based on prevailing market prices of all items included in the Annual Procurement Plan of the Municipal Government, which shall be used as reference in the preparation of all Purchase Requests;
2. Evaluate and determine estimates based on adequate detailed engineering in the case of Infrastructure Projects, and reflect the quality, supervision and risk and inflationary factors associated with the types of Goods or Infrastructure Projects to be procured;

3. Check and coordinate with Department/Office Heads concerned as to price estimates stipulated in each Purchase Requests.
4. When directed, shall attend Bids and Awards Committee (BAC) meetings pre-procurement and pre-bidding conferences, and/or during bidding proper, to answer and/or justify matters needing clarifications and solutions.
5. Perform other related functions and duties as may be directed by competent authorities.

SECTION 3. INCORPORATION. The Price Monitoring Committee (PMC) is hereby declared and considered as among the Local Bodies.


SECTION 4. APPROPRIATIONS. Until appropriation is provided, operational expenses of the Price Monitoring Committee (PMC) shall be charged to the Office of the Municipal Mayor.

EFFECTIVITY. This Order shall take effect immediately.
