## **EXECUTIVE ORDER NO. 17-135**

CREATING THE MUNICIPAL COUNCIL FOR EARLY CHILDHOOD CARE AND DEVELOPMENT C (MCECCD) AND PRESCRIBING ITS MEMBERSHIP AND FUNCTIONS THEREFORE

WHEREAS, R.A. 10410 otherwise known as the Early Years Act declares that the State "recognizes the age from zero (0) to eight (8) years as the first crucial state of educational development of which the age from zero to four (4) years shall be the responsibility of the Early Childhood Care and Development (ECCD) Council while ages five (5) to eight (8) years shall be the responsibility of the Department of Education (DepEd);

WHEREAS, Executive Order Nos. 806 and 778 consolidated early government organizations tasked on children's welfare and the same is transferred to the ECCD Council as the primary agency to support the government's ECCD programs, covering health, nutrition and early leaning for children aged 0-4 years;

WHEREAS, the Municipal Government of Bayog, Zamboanga del Sur, as partner on early childhood care and development becomes inevitable to support the National ECCD Council on its operations and activities thus the need to create a local counterpart Council;

NOW, THEREFORE, I, LEONARDO L. BABASA, JR., Municipal Mayor, by virtue of the powers vested in me as Local Chief Executive of the Municipality of Bayog, Zamboanga del Sur, do hereby Order:

SECTION 1. CREATION AND COMPOSITION OF MCECCD. The Municipal Council for Early Childhood Care and Development (MCECCD) is hereby created to be composed and whose membership may from time to time be augmented as the need arises:

SECTION 2. FUNCTIONS, DUTIES, AND RESPONSIBILITIES. The MECCDC shall perform the functions, duties, and responsibilities as are embodied under the governing law, rules, and regulations; carry out instructions and guidelines that may henceforth be issued by the National ECCD Council and perform other functions as may be directed by competent authorities.

SECTION 3. INCORPORATION TO THE MUNICIPAL LOCAL BODIES. The Municipal ECCD Council is hereby included in the Municipal Local Bodies and shall be entitled a representative to the MDC, MPOC, MDRRMC, and other applicable local bodies.

SECTION 4. EFFECTIVITY. This Order shall take effect immediately.
