## **EXECUTIVE ORDER NO. 17-144**

### **CREATING THE FAMILY DEVELOPMENT SESSIONS (FDS) TEAM IN THE MUNICIPALITY OF BAYOG, ZAMBOANGA DEL SUR AND DEFINING ITS DUTIES AND RESPONSIBILITIES**

WHEREAS, Section 16, of R.A. 7160 otherwise known as the Local Government Code of 1991 states that: "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants."

WHEREAS, in the attainment of its mission, it becomes incumbent to implement necessary measures to address multifarious problems, inequities, disparities and population needs in accordance with government laws, rules and regulations and ordinances thus ensuring a clean, orderly, and peaceful community.

NOW THEREFORE, I, LEONARDO L. BABASA, JR., Municipal Mayor, by virtue of powers vested upon me by law as Local Chief Executive of Bayog, Zamboanga del Sur, do hereby Order:

**SECTION 1. CREATION.**– The FAMILY DEVELOPMENT SYTEM (FDS) TEAM is hereby created, organizing its membership and defining its duties and responsibilities as are stipulated in succeeding sections hereto.

**SECTION 2. COMPOSITION.** The FDS Tean shall be composed of the following Officials and Employees, which could be augmented as the need arises:

**SECTION 3.** The Family Development Systems (FS) Team shall have the following functions, duties and responsibilities:


1. Facilitate or serve as resource persons based on the set schedule and crafting/enhancing modules based on the needs of partner beneficiaries;
2. FDS team are responsible for planning, conducting and monitoring the FDS conduct in the area;

3. FDS team can also recommend policy/module development/enhancements to the advisory committees.
4. Conduct information drive on the existing social services at all levels during FDS;
5. To help campaign on the establishment of backyard/communal gardens in Pantawid Pamilya households/communities;
6. Conduct disaster preparedness and environmental protection sessions.
7. Perform other duties and responsibilities as may be provided by law and/or competent authorities concerned.


SECTION 4. INCORPORATION. The Family Development Systems (FDS) Team is hereby declared and considered as among the Local Bodies of the Municipal

SECTION 5. EFFECTIVITY. This Order shall take effect immediately.
