EXECUTIVE ORDER NO.17-145

CREATING THE LOCAL COUNCIL FOR THE CULTURE AND THE ARTS (LCCA) IN THE MUNICIPALITY OF BAYOG, ZAMBOANGA DEL SUR AND DEFINING ITS DUTIES AND RESPONSIBILITIES

WHEREAS, Section 16 of the Local Government Code of 1991 provide among others that Local Government Units play an important role in the development; promotion and preservation of Filipino Culture; to encourage the participation of the people in the development and preservation of Filipino identity; and, to ensure and support among others the preservation and enrichment of culture;

WHEREAS, to promote the Filipino Culture, it becomes impending to instill nationhood and cultural unity, and raise the level of consciousness of the people on cultural values, conservation of historical and cultural heritage and resources must be done to remind us of our national culture and identity;

WHEREAS, in pursuit of these mandates, goals and objectives, there is a need to create bodies at the local levels that will ensure the preservation, enrichment and promotion of the Filipino national culture.

NOW THEREFORE, I, LEONARDO L. BABASA, JR., Municipal Mayor, by virtue of powers vested upon me by law as Local Chief Executive of Bayog, Zamboanga del Sur, do hereby Order:

SECTION 1. CREATION. The Local Culture and the Arts Council (LCCA) is hereby created in the Municipality of Bayog, Zamboanga del Sur, whose initial membership with duties and responsibilities as are stipulated in succeeding sections hereof:

SECTION 2. COMPOSITION. The LCCA shall be composed of the following which shall be augmented as the need arises:

SECTION 3. The Local Council for the Culture and Arts shall have the following functions, duties, and responsibilities:

- a. Prepare an Annual Plan on culture and the arts consonant to the Medium Term Philippine Development Plan for Culture and the Arts to be integrated in the Local Development Plan;
- b. Formulate programs and recommendations to develop local cultural and artistic talents;
- c. Ensure the protection preservation and conservation of the local and historical heritage;
- d. In coordination with the private sector, conduct cultural events such as cultural festivals, competition, lectures, seminars, for a and symposia, set up exhibits during fiestas and other related activities;
- e. Conduct periodic consultations with all stakeholders to identify grassroots-based cultural concerns, issues and agenda;
- f. Encourage the development of local cultural industries;
- g. Conduct periodic inventory of local cultural objects and sites in coordination with the National Commission for Culture and the Arts; and
- h. Coordinate with existing Local Culture and Arts Councils
- i. Perform other related duties and responsibilities as may be directed by law, ordinance, and local policies

SECTION 4. MEETINGS. Regular and Special meetings shall be held on the day, time, and place as maybe fix by Council, minutes of which shall be furnished the Offices of the Municipal Mayor, Vice Mayor, and Sanggunian Bayan, for their respective information reference, and necessary action.


SECTION 5. INCORPORATION. The Family Development Systems (FDS) Team is hereby declared and considered as among the Local Bodies of the Municipal
