



**EXECUTIVE ORDER NO. 17-158**

**REORGANIZING THE MUNICIPAL DEVELOPMENT COUNCIL-EXECUTIVE COMMITTEE (MDC-EXECOM) FOR THE IDENTIFICATION AND LISTING OF PRIORITY PROJECTS UNDER THE ASSISTANCE TO THE MUNICIPALITIES PROGRAM (AMP) OF BAYOG, ZAMBOANGA DEL SUR**

WHEREAS, the MDC-EXECOM was already organized as mandated by the Local Government Code of 1991;

WHEREAS, the policy guidelines of the Department of Interior and Local Government (DILG) for the preparation of Assistance to Municipalities Program (AMP) favors a larger number of representation from the Civil Society organizations (CSOs);

WHEREAS, the same guidelines states that CSO, PO and private sector representatives in the conduct of project identification should be at least equal to the number of government representation in the MDC-Executive Committee;

NOW THEREFORE, I, LEONARDO L. BABASA, JR. by virtue vested in me as Local Chief Executive of Bayog, Zamboanga del Sur, do hereby order;

SECTION. 1. Reorganization of the Municipal Development Council- Executive Committee. The Municipal Development Council – Executive Committee shall compose the following:

SECTION II.. Powers, Functions and Responsibilities of the Executive Committee. The Executive Committee shall have the following powers, functions and responsibilities:

- (i) Ensure that the decisions of the Council are faithfully and effectively carried out;
- (ii) Act on matters that need the immediate attention and/or action of the Council;
- (iii) Formulate policies in accordance with the general principles laid down by the Council;
- (iv) Act on other matters which the Council, by resolution, may so authorize; and
- (iv) Identify projects for Assistance to Municipalities Program.

SECTION III. Meetings. The Executive Committee shall hold regular meetings at least once every quarter on a day or days that may be agreed upon during its initial meeting.

This order shall take effect immediately and shall amend / or repeal all municipal orders inconsistent herewith.
