EXECUTIVE ORDER NO. 15-099
CREATION OF LOCAL CLIMATE CHANGE ACTION PLAN (LCCAP) CORE TEAM

Date: 03.16.16

WHEREAS, Section 14 of the Republic Act 9729 otherwise known as Climate Change Act 2009 provides among others that the LGU shall be the frontline agencies in the formulation, planning and implementation of Climate Change Action Plans (CCAP) in their respective areas, consistent with the provisions of the Local Government Code, the Framework and the National Climate Change Action Plan;

WHEREAS, it further states that the Local Chief Executive shall appoint the responsible person for the formulation and implementation of the Local Action Plan; and,

WHEREAS, the LGU Guidebook on the formulation of the Local Climate Change Action Plan also provides that the Local Chief Executive, shall form the LCCAP Core Team who will lead, oversee and ensure that Local Climate Change Action Plan LCCAP will be formulated, eventually approved, implemented, regularly monitored and updated when necessary.

NOW, THEREFORE, I, LEONARDO L. BABASA, JR., Municipal Mayor, by virtue of the powers vested in me as Local Chief Executive of Bayog, Zamboanga del Sur, do hereby order:

SECTION 1. COMPOSITION. The Local Climate Change Action Plan (LCCAP) Core Team will be composed of the following:

SECTION 2. DUTIES AND RESPONSIBILITIES. The LCCAP Core Team shall perform the following responsibilities to wit:

1. Conduct Vulnerability Assessment and Anticipatory Adaptation and Management Process in 28 barangays.
2. Oversee and ensure that an LCCAP is formulated and implement upon approval by the Office of the Sangguniang Bayan.
3. Regularly monitor and update when necessary the LCCAP.

SECTION 3. BUDGET ALLOCATION. The initial budget allocation in the amount of Fifty Thousand Pesos (Php50,000.00) is hereby allocated from the Local Disaster Risk Reduction and Management Fund for its operation and maintenance expenses.


SECTION 4. EFFECTIVITY. This Order shall take effect immediately.

SECTION 5. Let copies of this Order be furnished the Offices of the Provincial Governor, Province of Zamboanga del Sur, the MDGH-LDRRMO of the province, the Municipal Vice Mayor, for their respective review and guidance.
