## **EXECUTIVE ORDER NO. 16-105**

Date:

CREATING THE LOCAL PRICE COORDINATING COUNCIL (LPCC) IN THE MUNICIPALITY OF BAYOG PURSUANT TO REPUBLIC ACT NO. 7581 OTHERWISE KNOWN AS THE PRICE ACT.

WHEREAS, Republic Act No. 7581 otherwise known as "The Price Act" provides protection to consumers by stabilizing the prices of basic commodities and prescribing measures against undue price increases during emergency situations and like occasions;

WHEREAS, Section 4 thereof created a Price Coordinating Council to carry out the intents and purposes of the said Act, thereby giving powers and responsibilities to various government agencies to ensure that consumers does not suffer undue price increases;

WHEREAS, it becomes proper and necessary to have the same Body to undertake such duties and responsibilities municipality-wide:

NOW, THEREFORE, I, LEONARDO L. BABASA, JR., Municipal Mayor, by virtue of the powers vested in me as Local Chief Executive of Bayog, Zamboanga del Sur, do hereby Order:

SECTION 1.. There is hereby created a LOCAL PRICE COORDINATING COUNCIL (LPCC) in the Municipality of Bayog to be composed of the following:

SECTION 2. The Local Price Coordinating Council shall perform the duties and functions as are enumerated under Section 12 of RA 7581 and as may be prescribed in the Implementing Rules and Regulations and approved policies of LPCC.

SECTION 3. Pending specific provision in the Annual Budget, expenses shall be charged to the Office of the Municipal Mayor and/or to any applicable appropriations in the annual budget.

SECTION 4. EFFECTIVITY. This Order shall take effect immediately.
