MUNICIPAL ORDINANCE NO. 10-45-08

AN ORDINANCE PROHIBITING THE THROWING AND BURNING OF RICE HUSK BY INDIVIDUAL IN RIVERS, CREEKS, CANAL, LAKES AND VACANT LOTS NEAR ROADS & STREETS AND IMPOSING PENALTIES FOR THE VIOLATION THEREOF.

BE IT ORDAINED by the 10^{th} Sangguniang Bayan of Bayog, Zamboanga del Sur on its 32^{ND} Regular Session held at the Municipal Session Hall on March 17, 2008 at 9:00 am.:

- SECTION 1 SCOPE: In compliance to existing laws and other statutes in relation to health, sanitation and balance ecology, it is but proper to invoke an ordinance regulating the existence of activities that would redound to the detriment of the health of the general public and pose a threat to imbalance ecology.
- SECTION II PROHIBITED ACTS: It shall be unlawful for any person to throw and burn rice husk in rivers, creeks, canals, lakes and in any vacant lot near roads and streets.
- SECTION III PENALTY: Any person caught violating this ordinance shall be penalized by a fine of One Thousand Five Hundred (P1,500.00) pesos or an imprisonment of six months or both fine and imprisonment at the discretion of a proper court.
- SECTION IV REPEALING CLAUSE: Any ordinance promulgated prior to this ordinance shall be repealed and modified accordingly.
- SECTION V EFFECTIVITY: This ordinance shall take effect after three (3) consecutive weeks of publication in a newspaper of general circulation in the Province of Zamboanga del Sur.
