**MUNICIPAL ORDINANCE NO. 10-66-09**

BE IT ENACTED, by the Sangguniang Bayan of Bayog, Zamboanga del Sur, on its 95<sup>TH</sup> Regular Session held at the Municipal Session Hall on July 6, 2009 at 9:00 A.M.:

**TITLE: AN ORDINANCE DIRECTING ALL BARANGAY CAPTAINS TO REQUIRE TREE PLANTING CERTIFICATE ISSUED BY A PUROK PRESIDENT CERTIFYING THAT SUBJECT PERSON HAS PLANTED AT LEAST THREE (3) TREES OF ANY SPECIE EXCEPT GEMELINA BEFORE THE ISSUANCE OF BARANGAY CLEARANCE AND PENALIZING FOR THE VIOLATION THEREOF**

**SCOPE:** There is a pressing demand of establishing measures to minimize if not eradicate any catastrophe caused by untoward activities of human being against Mother Earth. One of the best remedial measure is simply to plant trees which can ultimately bring freshness and coolness in the air and prevent further destruction of the environment brought about by global warming.

**REGULATED ACTS:**

- a. It shall be unlawful for Barangay Captains to issue Barangay Clearance without a certification issued by a Purok President certifying that subject person has planted at least three (3) trees of any specie except Gemelina.
- b. Police and Mayor's Clearance shall not be issued without securing first the corresponding Barangay Clearance.

**PENALTY:** Any authorized personality caught violating this ordinance shall be penalized by a fine of Two Thousand Five Hundred (P2,500.00) Pesos or an imprisonment of not less than (1) month and not more than six (6) months or both fine and imprisonment at the discretion of the court.

**REPEALING CLAUSE:** Any ordinance or part thereof inconsistent to this ordinance shall be repealed accordingly.


**EFFECTIVITY:** This ordinance shall take effect after three (3) consecutive weeks of publication of a news paper of local circulation.

ADOPTED this 6<sup>TH</sup> day of July 2009, on motion of Hon. Saturnino O. Amor, duly seconded.


