MUNICIPAL ORDINANCE NO. 10-73-10

BE IT ENACTED, by the 10<sup>th</sup> Sangguniang Bayan of Bayog, Zamboanga del Sur, on its 126<sup>th</sup> Regular Session held at the Municipal Session Hall on March 1, 2010 at 9:00 A.M.:

**SECTION 1 - TITLE - AN ORDINANCE STRICTLY PROHIBITING THE SMOKING INSIDE UTILITY VEHICLE SUCH AS BUT NOT LIMITED TO PUBLIC UTILITY VAN (PUV) PUBLIC UTILITY JEEP (PUJ), AND PUBLIC UTILITY BUS (PUB) PLYING FROM BAYOG TO ANY ROUTE WITHIN AND OUTSIDE THE MUNICIPALITY OF BAYOG AND PENALIZING FOR THE VIOLATION THEREOF.**

**SECTION 2 - REGULATED ACTS -** It shall be unlawful for any person to smoke inside the utility vehicle such as, but not limited to jeepneys, buses, tricycles and other similar vehicles.

**SECTION 3 - PENAL CLAUSE -** The following penalties shall be imposed on violators of this Ordinance: a) First Offense: Warning; b) Second Offense: Fine of 200.00; c) Third Offense Fine of P1,500 or an imprisonment of not less than three (3) days but not more than ten (10) days or at the discretion of the Court; d) The franchise of a public conveyance shall be suspended for at least three (3) days but not more than one (1) week upon third and subsequent offense transpiring therein or the vehicle used shall be prohibited from plying within the municipality as public conveyance.)


**SECTION IV - EFFECTIVITY -** This Ordinance shall take effect after three (3) consecutive weeks of publication in a newspaper of general circulation in the Province of Zamboanga del Sur.
