

**MUNICIPAL ORDINANCE NO. 12-115-13**

BE IT ORDAINED by the 12<sup>th</sup> Sangguniang Bayan of Bayog, Zamboanga del Sur, on its 9<sup>th</sup> Regular Session held at the Municipal Session Hall on September 2, 2013 at 9:00 in the morning.

**SECTION 1. TITLE** - This Ordinance shall be known as "**: AN ORDINANCE REGULATING THE SPEED LIMIT OF ALL MOTORIZED VEHICLE TRAVERSING WITHIN THE URBAN CENTER (POBLACION AND KAHAYAGAN) OF THE MUNICIPALITY OF BAYOG, ZAMBOANGA DEL SUR**".

**SECTION II. SCOPE** - All types of motorized vehicle operating and plying within the urban center of Bayog, Zamboanga del Sur.

**SECTION III. REGULATORY ACTS** - It shall be unlawful to all types of vehicles operating and plying within the urban center (*Poblacion and Kahayagan*) of the Municipality of Bayog, Zamboanga del Sur to exceed the speed limit of 30kph.

**SECTION IV. EXEMPTIONS.** The rates of speed hereinabove prescribed shall not apply to the following:

- 1.) A physician or his driver when the former responds to emergency calls;
- 2.) The driver of a hospital/health center ambulance on the way to and from the place of accident or other emergency;
- 3.) Any driver bringing a wounded or sick person for emergency treatment to a hospital, clinic, or any other similar place;
- 4.) The driver of a motor vehicle belonging to the Armed Forces while in use for official purposes in times of riot, insurrection or rebellion;
- 5.) The driver of a vehicle, when he or his passengers are in pursuit of a criminal;
- 6.) A law-enforcement officer who is trying to overtake a violator of traffic laws; and
- 7.) The driver officially operating a motor vehicle of any fire department, provided that exemption shall not be construed to allow, unless or unnecessary, fast driving or drivers aforementioned.

**SECTION V. PENAL PROVISION.** Any driver caught violating this ordinance shall be penalized by the following:

1 <sup>st</sup> Offense	-	Reprimand
2 <sup>nd</sup> Offense	-	Fine of P200.00 and pass an orientation on his/her violations committed
3 <sup>rd</sup> Offense and thereafter	-	Fine of P500.00

**SECTION VI. REPEALING CLAUSE** - Any Ordinance part or in toto found inconsistent with this Ordinance is hereby modified or repealed.

**SECTION VII. EFFECTIVITY.** This Ordinance shall take effect after three (3) consecutive weeks of publications in a public places.




