

**MUNICIPAL ORDINANCE NO. 12-121-13**

**AN ORDINANCE PROHIBITING THE WEARING OF GENUINE AND LOOK-ALIKE MILITARY OR POLICE UNIFORMS BY CIVILIANS REGARDLESS OF AGE IN THE MUNICIPALITY OF BAYOG, ZAMBOANGA DEL SUR**

BE IT ORDAINED by the 12<sup>th</sup> Sangguniang Bayan of Bayog, Zamboanga del Sur on its 19<sup>th</sup> Regular Session held at the Municipal Session Hall on November 11, 2013 at 9:00 A.M.

**SECTION I SCOPE** – It is known there are civilians fond of wearing genuine or look-alike military uniform devoid of knowledge that it would create a suspicious-looking character which in fact, disadvantageous and hazardous to themselves particularly during unstable peace and order condition.

**SECTION II PROHIBITION** – Civilians, regardless of age, are strictly prohibited to wear the same in plain view or in public, during night time, and in places apparently considered critical.

**SECTION III EXEMPTIONS** – The following however, are exempted from wearing military or police uniforms;

- a. Member of the Philippine National Police.
- b. Officials and enlisted elements of the Armed Forces of the Philippines (AFP)
- c. ROTC Cadets and Cadettes during their actual training/instruction schedules only.
- d. CAFGU, Security Guard and SCAA elements during actual duties and in areas of assignment.

**SECTION IV. PENAL PROVISION.** Any civilian caught violating this ordinance shall be penalized by the following:

1 <sup>st</sup> Offense	-	Reprimand
2 <sup>nd</sup> Offense	-	Fine of P200.00
3 <sup>rd</sup> Offense and thereafter	-	Fine of P500.00

**SECTION V : PERSON AUTHORIZED TO CONDUCT ARREST WITHIN BARANGAY LEVEL**  
The Barangay Chairman, thru this Ordinance, is also authorize to cause or conduct arrest if the violation is committed in his barangay and to impose the same penalty as provided.

**SECTION VI. REPEALING CLAUSE** – Any Ordinance part or in toto found inconsistent with this Ordinance is hereby modified or repealed.

**SECTION VII. EFFECTIVITY.** This Ordinance shall take effect after three (3) consecutive weeks of publications in a public places.


