MUNICIPAL ORDINANCE NO. 12-138-14

BE IT ORDAINED by the 12th Sangguniang Bayan of Bayog, Zamboanga del Sur on its 56th Regular Session held at the Municipal Session Hall on August 18, 2014 at 9:00 a.m.

SECTION I. TITLE - AN ORDINANCE PROHIBITING ANY PERSON TO GATHER FLOATING LOGS, WOODEN DEBRIS AND DRIFT WOODS WHEN FLOOD IS OCCURRING EITHER IN SIBUGUEY, DIPILI AND DEPORE RIVERS, ALL OF BAYOG, ZAMBOANGA DEL SUR.

SECTION II. SCOPE - It is usual when flood is occurring that there are individuals who dared to gather floating logs, wooden debris and drift woods, and there were recorded incidents in the past that some lost their lives when carried away by the strong current leaving great sufferance to the surviving family, as it often takes several days before the remains is recovered somewhere far down the river.

SECTION III. PENALTY: Any person dares in gathering floating logs, wooden debris and drift woods is penalized

| For the 1 st Offense | - One (1) day community service and reprimand |
| 2 nd Offense | - Two (2) days community service and reprimand
(If the transgressor is a minor, both the minor and the parents shall undergo counseling at the Office of the DSWD) |
| 3 rd Offense | - A fine of P2,500 and imprisonment of one (1) month for the adult transgressor, and the confinement of a minor under the care and custody of the DSWD. |

(The parent of the minor shall suffer the same penalty as with the adult transgressor at a fine of P2,500 and one (1) month imprisonment for being irresponsible, neglectful and of exposing the life of his child in absolute danger of drowning.)


SECTION IV. EFFECTIVITY: This Ordinance shall take effect after three (3) weeks of posting in conspicuous places and publication in the local newsletter of the Local Government of Bayog, Zamboanga del Sur.


