## **MUNICIPAL ORDINANCE NO. 13-216-17** AN ORDINANCE STRICTLY PROHIBITING THE USE OF MOSQUITO NETS AND TINY-HOLED FISHING MATERIALS IN THE RIVERS, LAKES AND STREAMS IN THE MUNICIPALITY OF BAYOG, ZAMBOANGA DEL SUR.

BE IT ENACTED, by the 13th Sangguniang Bayan of Bayog, Zamboangadel Sur on its 52nd Regular Session held at the Municipal Session Hall on August 14, 2017 at 9:00 a.m.

SECTION I - SCOPE: The use of mosquito nets and tiny-holed fishing materials contributed to the depletion of certain fresh water species important to man's survival. Our rivers, lakes and streams no longer provide enough foods to sustain the needs of the inhabitants once dependent on said water sources as means of living. Aquatic species useful to man are alarmingly vanishing, hence creating an Ordinance is necessary.

SECTION II - PROHIBITION: It is strictly prohibited to any person or group of persons who shall use mosquito nets and tiny-holed fishing materials to catch/gather aquatic species in our rivers, lakes and streams within the Municipality of Bayog.

SECTION III - PENALTY: Violation of this Ordinance shall subject the offender(s) to the following:

1<sup>st</sup> Offense . . . . . . . a fine of P1,000.00 2<sup>nd</sup> Offense . . . . . a fine of P2,000.00

 $3^{\text{rd}}$  Offense . . . . . . . . . a fine of P2,500.00, or an imprisonment of 30 days, or both fine and imprisonment as to the discretion of the

SECTION IV. AUTHORITY OF THE BARANGAY TO ENFORCE - The Barangay, thru its Chairman is authorize to enforce this Ordinance, and shall be entitled to collect 50% of the fine imposed for every violation committed.

SECTION V. EFFECTIVITY - ThisOrdinance shall take effect after three (3) consecutive weeks of Postingin conspicuous places and publication in the local news letter of the MunicipalityofBayog, Province of Zamboanga del Sur.
