



**MUNICIPAL ORDINANCE NO. 13-223-18**

BE IT ENACTED, by the 13<sup>th</sup> Sangguniang Bayan of Bayog, Zamboangadel Sur on its 77<sup>TH</sup> Regular Session held at the Municipal Session Hall on February 12, 2018 at 9:00 a.m.

**SECTION I - AN ORDINANCE IMPOSING FINES TO ANY MEMBER OF THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF BAYOG WHO COMMITS ABSENCES DURING SESSION WITHOUT PRIOR NOTIFICATION TO THE PRESIDING OFFICER OR THE SECRETARY TO THE SANGGUNIANG BAYAN.**

**SECTION II- SCOPE:**Every member of the Sanggunian Bayan of the Municipality of Bayog shall attend all the regular and special sessions of the Sanggunian. As a general rule; it is the duty and responsibility of individual member to attend sessions and observe proper deportment and decorum during sessions, as expressly provided under **Book I – General Provisions Chapter 3 Section 50 paragraph (5) of the Local Government Code of 1991 (RA. 7160).**

**SECTION III- EXEMPTING CIRCUMSTANCES:**

- (a) In case of emergency between life and death, notification is no longer required.
- (b) If any member of the sanggunian is on leave, official business, seminars (or in **simple** sickness) notification is no longer required.
- (c) If any member of the sanggunian is in sickness or admitted to the hospital, **doctor's certification** is required.
- (d) If any member of the sanggunian notifies or ask permission from the presiding officer prior to the scheduled session is exempted, and any reason thatis not within **Section III** of this ordinance is not accepted.

**SECTION IV- IMPOSITION OF FINES:**Any member of the sanggunian of the Municipality of Bayog who violates **Section III** of this Ordinance is subject to the following fines:

- 1<sup>st</sup> Offense – reprimand and a **fine** of 1, 000.00 pesos
- 2<sup>nd</sup> Offense – a **fine** of 1, 500.00 pesos
- 3<sup>rd</sup> Offense – a **fine** of 2, 500.00 pesos

**SECTION V – TREASURER DESIGNATE:** Any responsible member of the sanggunian is eligible to be designated as treasurer.

**SECTION VI - ACCRUAL OF FUNDS:**Fines collected by the treasurer of the sanggunian shall be deposited to any bank of choice by the sanggunian, and shall be withdrawn only for use in such noble purposes as agreed/approved by the majority members of the Sangguniang Bayan present..

**SECTION VII - REPEALING CLAUSE-** Any ordinance promulgated prior to this ordinance shall be repealed/modified accordingly.

**SECTION VII- EFFECTIVITY-** This ordinance shall take effect upon approval.
