MUNICIPAL ORDINANCE NO. 9-19-05

AN ORDINANCE PROHIBITING THE STORING OF FLAMMABLE, EXPLOSIVE, OR HIGHLY COMBUSTIBLE MATERIALS WITHIN THE URBAN CENTER OF THE MUNICIPALITY OF BAYOG, ZAMBOANGA DEL SUR.

SECTION 1 - REGULATED ACT - No person shall keep or store in his place of Business or elsewhere within the Urban Center of this Municipality any flammable or highly combustible material, without first securing a permit therefore from the Municipal Mayor thru the Provincial Fire Marshal and paying the corresponding permit fees imposed under existing Tax Ordinances.

SECTION II - ADMINISTRATIVE PROVISIONS

- 1) The Provincial Fire Marshal or any official designated as such or his Duly Authorized Representative shall have supervision over the location and manner of storing flammable or highly combustible materials in accordance with promulgated Rules and Regulations on fire prevention and protection. If in his Judgment, the location and manner of storing such materials constitute a fire hazard, he shall issue an order to the possessor thereof directing that the same shall be removed within 24 hours.
- 2) No permit shall be issued for storage of gun powder, explosive, blasting supplies or ingredients therefore, unless there is a prior clearance or authorization, issued by the Provincial Fire Marshal or his authorized Representative.
- SECTION III APPLICABILITY CLAUSE All other matters relating to Fire Inspection and Issuance of Permit thereof shall be governed by the pertinent provision of PD 1185 (Fire Code of the Philippines) and other existing laws, Rules and Regulations.
- SECTION IV PENALTY Any violation of the provisions of this Ordinance shall be punished by a fine of not more than Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment of not more than six months, or both fine and imprisonment, at the discretion of the court.
- SECTION V EFFECTIVITY This Ordinance shall take effect after three (3) consecutive weeks of publication in a newspaper of general circulation in the Province of Zamboanga del Sur.
