MUNICIPAL ORDINANCE NO. 9-33-07

BE IT ORDAINED by the 9th Sangguniang Bayan of Bayog, Zamboanga del Sur on its 121st Regular Session held at the Municipal Session Hall on January 22, 2007 at 9:00 A.M.

SECTION 1. TITLE - AN ORDINANCE PROHIBITING THE PEDDLING OF FRESH FISH FROM THE PUBLIC MARKET TO: LYDIA LUCERO'S RESIDENCE; BAILEY BRIDGE; SIBUGUEY DAM AND BAYOG NATIONAL HIGH SCHOOL.

SECTION 11 - SCOPE: Regular fresh fish businessmen displaying their items inside the wet section of the public market are greatly affected by the proliferation of fresh fish peddler operating near the Public Market.

SECTION III - PENALTY - Any person/s caught violating this Ordinance shall be penalized by the following, to wit:

| 2 nd Offense | - | Fine of not more than Five (P500.00) Hundred Pesos. |
| 3 rd Offense | - | Fine of not less than One Thousand (P1,000.00) Pesos and confiscation of the item/s sold. |

SECTION IV - EFFECTIVITY - This ordinance shall take effect after three (3) consecutive weeks of publication in a newspaper of general circulation in the Province of Zamboanga del Sur.
