BABASA JR, BAYOG, ZAMBOANGA DEL SUR TO SIGN A MEMORANDUM OF AGREEMENT WITH PAGADIAN DIAGNOSTIC CENTER REPRESENTED BY ITS OWNER MARIA CHRISTINA M. CABAHUG TO CONDUCT RANDOM DRUG TEST TO ALL MUNICIPAL EMPLOYEES OF THE LOCAL GOVERNMENT OF BAYOG.**

WHEREAS, in response to the call of nation-wide campaign for the eradication of drug addiction problem and to promote and maintain the integrity, decency and moral responsiveness in the government service, the Local Government of Bayog with the personnel of Pagadian Diagnostic Center conducts random drug test to all local government employees this municipality;

WHEREAS, Pagadian Diagnostic Center provides the medical laboratory services while the local government shoulders the necessary expenses incurred in the conduct of drug testing examination;

WHEREAS, this body found it appropriate and proper;

NOW THEREFORE

BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Bayog, Zamboanga del Sur to authorize Honorable Mayor Leonardo L. Babasa, Jr., Bayog, Zamboanga del Sur to sign a Memorandum of Agreement with Pagadian Diagnostic Center represented by its owner Maria Christina M. Cabahug to conduct Random Drug Test to all Municipal Employees of the Local Government of Bayog.
