**RESOLUTION NO. 1434, S. 2017**

**A RESOLUTION DECLARING THE MUNICIPALITY OF BAYOG,  
ZAMBOANGA DEL SUR UNDER THE STATE OF IMMINENT DANGER.**

**WHEREAS**, PAGASA Weather Bulletin released extreme warning that Tropical Storm Vinta will hit the Philippines particularly in Mindanao including Zamboanga Peninsula;

**WHEREAS**, considering that the *Municipality of Bayog* is in the heartland of the three adjoining provinces of Zamboanga Peninsula, and both sides of the town proper lie the two (2) big rivers (*Sibugay River in the East, and Dipili River in the West*) that notoriously known to claim lives of animals and men and destroyed crops and properties during rainy days of the year;

**WHEREAS**, that the occurrence of this Super Typhoon Vinta would eventually caused massive evacuation to the inhabitants near the river banks to safer areas to avoid loss of lives;

**WHEREAS**, areas prone to landslides might experience the same;

**WHEREFORE**, on motion of Hon. Horace Paul T. Anlap and seconded by Hon. Cerillo B. Carcueva, it was;

**RESOLVED** as it is hereby resolve to declare the Municipality of Bayog, Zamboanga del Sur under the State of Imminent Danger.
