RESOLUTION NO. 1440 A, S. 2018
A RESOLUTION DECLARING THE MUNICIPALITY OF BAYOG,
ZAMBOANGA DEL SUR UNDER THE STATE OF CALAMITY.

WHEREAS, the recently occurring Tropical Typhoon Vinta caused a massive evacuation of 2,022 affected families inhabiting in flood-prone areas of the Municipality of Bayog with a total number of 8,787 individuals;

WHEREAS, reported crop damage reached to 59.3 hectares rice and 8.7 hectares for corn, with an estimated value of P899,400.00;

WHEREAS, the report further states that damages on infrastructures respectively reached as follows;
