RESOLUTION NO. 1472, S. 2018

**A RESOLUTION IMPOSING THE IMMEDIATE TEMPORARY CLOSURE OF BALUMBONAN
SUBMERGE RIVER CAVE AND LAMARE CAVE OF THE MUNICIPALITY OF BAYOG,
ZAMBOANGA DEL SUR FOR PROTECTION AGAINST VANDALISM, AS WELL AS
PRESERVATION, BEAUTIFICATION AND DEVELOPMENT.**

WHEREAS, like other places of the country, the Municipality of Bayog has several existing natural wonders that possibly attract local and foreign tourists if preservation, beautification and development are fully introduced;

WHEREAS, among the potential tourist attractions are the Balumbonan submerge river cave and Lamare cave that are now in frequent visitations by the inhabitants of nearby barangays and the inhabitants of the adjacent municipalities;

WHEREAS, sad to note that there are reported incidents of vandalism inside that disfigured the natural beauty of the caves and the immediate surroundings;

WHEREAS, the Local Government enthusiastically desired to make Bayog famous as a tourist destination because of the existing natural wonders, hence it is just right and proper also to protect, and preserve the same

WHEREAS, the caves which are found to have been easy to vandalize are subject to speculation for temporary closure against public viewing and to open once more, only when restrictive, regulative and protective measures are then implementable;

NOW THEREFORE

BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Bayog, Zamboanga del Sur to impose the immediate temporary closure of Balumbonan Submerge River Cave and Lamare Cave of the Municipality of Bayog, Zamboanga del Sur for protection against vandalism, as well as preservation, beautification and development;

RESOLVED FURTHER, to furnish copies of this Resolution The Barangay Chairman of the concern barangays and The Tourism Officer of this Municipality for their information, immediate action and ready reference.
